3 Validity Period

3.1 Responses to this tender received from suppliers will be valid for a period of **90 days** counted from the closing date of the tender.

4 Submission of Tenders and Briefing session

- 4.1 Tenders should be submitted in a sealed envelope endorsed, FDC BID NO. 005/2018. The sealed envelope must be placed in the tender box at 33 Kellner, Westdene, Bloemfontein by no later than 12h00 on 11 MAY 2018. Compulsory briefing session should be held on the 20 April 2018 at 11:00 at FDC House, 33 Kellner, Westdene, Bloemfontein.
- 4.2 The closing date, company name and the return address must also be endorsed on the envelope. If a courier service company is being used for delivery of the bid document, the bid description must be endorsed on the delivery note/courier packaging to ensure that documents are delivered into the BID BOX.

TERMS OF REFERENCE

1. INTRODUCTION

The Free State Development Corporation (FDC) is a public entity established in terms of the FDC Act

6 of 1995. In terms of the Public Finance Management Act it is classified as a schedule 3D entity.

The mandate of the FDC is to establish and develop sustainable SMME's in the Free State Province by providing both financial and non-financial support services.

2. BACKGROUND

The concept of a One Stop Shop in the FDI space became an important phenomenon as a vehicle to deal with the administrative burden often experience by investors.

This imperative, if implemented collaborative across various government entities, will provide a more streamlined and investors-friendly policy environment. This implies that the investor will have to be in contact with one entity to obtain all necessary paperwork in one streamlined and coordinated process, rather than having to go through a maze of different government entities.

Rental of Office Space for the One Stop Shop Project at Bloemfontein Central Business District.

- The Free State Development Corporation with Department of Trade and Industry wants to rent office space in Bloemfontein Central Business District.
- The contract period should be for five (5) years.
- Size of the lettable area should be between 700m² and 1000m².
- The offices should be white box (should be clean, have white walls, white ceiling with lights and floor finishing. The plumbing must be in good working condition as well as the electricity)
- The building/offices must have a good working air conditioning system.
 - The building should have parking facilities:
 - 20-30 Parking bays (Staff & Visitors);
 - Two access controls, one for cars parking and one for pedestrians walking in;
 - Close proximity to office.

• If there is no parking available in the building, alternative parking nearby should be provided.

- Building/offices should be disability friendly.
- The Owner should be in position of compliance certificates for the electricity, mechanical, fire and plumbing.


